

WELCOME TO PBA!

To assist you in finding authorized parking on campus, vehicles with a valid PBA permit may park in posted designated lots.

Please be aware of all designated parking areas as well as areas marked **No Parking**. The Department of Public Safety strictly enforces all parking regulations 24/7 and it is your responsibility to remain informed of these regulations while utilizing campus parking facilities.

Please Note: PBA does not enforce Parking regulations on any city roadways. The city of West Palm Beach has jurisdiction of all street parking.

Parking Registration

All vehicles on campus—including motorcycles, scooters and bicycles—must be registered with the Department of Public Safety and display a valid parking decal. Decals should be placed on the driver's side, rear window to avoid citations.

- Register online (instructions available at pba.edu/parking).
- For temporary and visitor passes, visit the Department of Public Safety
 office to register your vehicle and obtain a guest dash pass. Display your
 pass as soon as possible to minimize the risk of citation.

Parking decals are **not transferable**. If you sell your vehicle or bring a different vehicle to campus, update your registration immediately. The individual who registers the vehicle is responsible for any violations committed by anyone operating that vehicle.

The Department of Public Safety provides up-to-date parking regulations, permit information and fine schedules at **pba.edu/parking** (myPBA login required).

Visitor Parking

Visitors must register their vehicle with Public Safety to receive a temporary guest pass and will be assigned an available parking area for their stay.

Family Church Downtown and Memorial Presbyterian Church

Our neighboring churches provide additional parking for PBA vehicles displaying a valid parking decal. However, during special events, these lots may be closed to PBA parking. Please observe and adhere to all posted signage in these areas.

Accessible Parking

Vehicles using ADA-accessible spaces must display both a valid PBA parking permit and a state-issued disabled parking placard or license plate.

Lost/Stolen Decal

Report any lost or stolen decal as soon as possible to the Department of Public Safety.

Towing, Immobilization, Fines and Appeals

Vehicles found in violation of parking regulations may be cited, immobilized (booted) or towed if posing a danger to life or property. Charges and fines are assessed to the student's account. Unpaid fines will result in a hold on the student account, preventing actions such as course registration.

PARKING AREAS

Resident Parking Areas permit required

- A. Dixie Garage: Residential parking only, available 24/7. PBA Card access is provided with permit purchase. Guest and visitor passes are available at the Public Safety office. Reserved employee spaces are posted on the lower floors. Motorcycle and scooter parking is available on the first floor only.
- B. Coastal Towers Parking Lot: Residential parking only, available 24/7. No guest or visitor spaces. Motorcycle and scooter parking is available in the southwest corner only.

Commuter and Employee Parking Areas permit required

- C. Family Church East Lot: Commuter and employee parking only. No overnight or Sunday parking.
- D. Chadbourne Parking Lot: Commuter and employee parking only. No overnight or Sunday parking.

Commuter Only Parking Areas permit required

- E. Watson Hall Parking Lot: Commuter parking only. No overnight parking.
- F. Borbe Hall Parking Lot: Commuter parking only. No overnight parking.
- Rinker Parking Lot: Commuter parking only. No overnight parking.
- Memorial Presbyterian Church West Lot: Commuter parking only. No overnight or weekend parking.
- Memorial Presbyterian Church North Lot: Commuter parking only. No overnight or weekend parking.

Reserved Parking Areas permit required

J. Sachs Hall Parking Lot: Admissions use only for scheduled tours of prospective students.
